

INFORMATION UNDER THE LAW ON THE PROTECTION OF PERSONAL DATA

Below is a list of terms used herein along with their meanings.

“**OYAK**”: It is the OYAK Group

“**ATAER MINING**”: It is Ataer Mining Industry and Trade Inc.

“**PDPL**”: Law no. 6698 on Protection of Personal Data

“**USER**”: They are real and legal persons who access the SITE by reading and accepting the provisions of TERMS OF USE, INFORMATION AND SECURITY AND PRIVACY POLICY UNDER THE LAW ON THE PROTECTION OF PERSONAL DATA and benefiting from the SITE within the scope of these terms and conditions.

“**SITE**”: It is the web site with named: www.ataermadencilik.com.tr

Within the scope of the Personal Data Protection Law No. 6698 ("PDPL"), ATAER MINING has the title of "Data Controller" as defined in the PDPL. As the Data Controller, we indicate that Personal Data will be processed, recorded, stored, preserved, updated and transferred when necessary. In this context, we declare that any transaction to be made on Personal Data by ATAER MINING, its consultants, shareholders or solution partners and other relevant persons will be considered as processing of personal data.

Your personal information will be recorded, stored, updated within the framework described below, disclosed to third parties, transferred, classified and processed in the ways listed in the PDPL, where permitted by the legislation.

PURPOSE AND LEGAL REASONS FOR PROCESSING PERSONAL DATA

Within the scope of the Turkish Commercial Code and the Labor Law No. 4857 and the legislation on commercial sales, to ensure that your job applications, orders, purchasing, payment and delivery stages are carried out smoothly, to determine the information of the job applicant, USER or SITE visitor accurately and completely, record the address and other necessary information; to arrange all records and documents, including contracts that will be the basis for processing in electronic (internet / mobile, etc.) or paper environment; to comply with the information retention, reporting and information obligations stipulated by the legislation, relevant administrations and institutions and other authorities; to provide other requested products/services and to fulfill the requirements of our commercial relationship in accordance with the relevant legislation.

PERSONS AND ORGANIZATIONS TO WHICH YOUR PERSONAL DATA MAY BE TRANSFERRED

Your personal data may be indirectly/directly transferred to the following within the scope of the relevant legislation: our domestic/foreign affiliates or subsidiaries, domestic/foreign/international, for which service/support/consultancy is received or cooperated or project/program/financing partner is provided by us, public / private institutions and organizations, solution partners, companies and other third parties or organizations.

OBTAINING YOUR PERSONAL DATA

Your personal data may be collected verbally, in writing or electronically, while using the SITE, filling out the necessary information for product orders, in your job applications, with your resume, with the notifications, correspondence and calls you send to us.

YOUR LEGAL RIGHTS ACCORDING TO PDPL

By applying to our company, in accordance with Article 11 of PDPL, you have the right to learn whether your personal data is processed; if so, to get the information about it, the purpose of processing and whether it is used in accordance with this purpose, and the 3rd parties in the country or abroad to whom the said data is transferred, to learn, your personal data incomplete or incorrect, to demand that they be corrected if they have been processed incorrectly. You have the right to request the deletion or destruction of your personal data within the framework of the conditions stipulated in Article 7 of the Law and to notify the third parties to whom the information is transferred about the transactions made by our company, to object to a result against you due to the analysis of your personal data exclusively by automated systems, and to demand the compensation of the damage if you suffer damage due to unlawful processing.

You will be able to use your rights stated here as in the PDPL as of 07.10.2016.

However, we reserve the right to demand the expenses to be incurred by our company for the fulfillment of your requests in accordance with the principles set forth in Article 13 of the PDPL titled "Application to the Data Controller".
