Evaluating the investment to be made in Hekimhan, Chairman of Malatya Chamber of Commerce and Industry (MTSO) and Board Member of Turkey Union of Chambers and Commodity Exchanges (TOBB) Oğuzhan Ata Sadıkoğlu said: “Our Malatya has been an important city for our country from past to present. It is one of the important steps to make an investment in Malatya that will reduce Turkey's dependence on foreign pellets by 50 percent.”

Expressing that the investment to be made in Hekimhan in partnership with OYAK Erdemir and Japanese JFE Steel is important, Malatya Chamber of Commerce and Industry (MTSO) President Oğuzhan Ata Sadıkoğlu said: “We care about investments that will increase employment and contribute to the national economy. We talked to OYAK officials and conveyed that we are ready for any kind of support.

We think that the investment, which will be a source of bread for thousands of our fellow citizens, will be operational in less than 55 months.”

acted upon.” Our goal is common, our goal is one. We conveyed that we exist in every step that will contribute to our national economy. We stated that as MTSO, we presented a blank check to OYAK Erdemir Company and that we are ready to contribute whatever we had to do. On behalf of our city, I would like to thank OYAK Erdemir Company, which will make such an important investment not only for our province, but also for our region and country.”

### “IN LESS THAN 55 MONTHS...”

Chairman Sadıkođlu said: “The factory, which will be established with an investment of 750 million dollars, is planned to be completed in 55 months, ie 4.5 years. This investment is of great importance not only for our Malatya but also for our region and our country. Thousands of our compatriots will be employed in the factory to be established. It will meet 3 million tons of Turkey's 6.2 million tons of pellet needs on its own. For such an important investment, we think that our President Recep Tayyip Erdoğan and our politicians will focus on this issue with sensitivity. For this investment, which has been on the agenda for many years, we expect the first excavation to be carried out quickly and to provide added value to the country's economy by completing it earlier than 4.5 years.”

Underlining that they care about investments that will increase employment and contribute to the national economy, Chairman Sadıkođlu said: “As MTSO, our goal is to grow the economy of Malatya, to increase the export figures of our province and to increase our employment rates. As MTSO, we want it to be known that we care about the factory to be established in Hekimhan, which will provide thousands of employments to our Malatya and a significant contribution to the national economy and that we support every step to be taken to bring this and similar investments to our city. Our aim since the day we took office is that the industry activities of Malatya are known in our region and spoken in our country. We will continue to work to increase investments that will increase employment and be a source where anyone earns his or her living.”
